## "Life together" means challenge and hope

**T**he news is filled with reports about cities cutting services. Libraries are closing. Flower gardens will go unplanted. One city in Colorado has replaced trash cans in parks with signs that ask visitors to pack out their garbage. Funds were eliminated for trash pick up.

While there are tentative signs of economic turnaround, funds for services that enhance a community's life together are likely to remain in short supply. Congregations know this, too.

Because offerings are less, there is a reduction in funds available for our life together as the Rocky Mountain Synod of the ELCA.

Our fiscal year ended on January 31, and offerings to the RMS from congregations had been expected to be \$3 million. Actual offerings to the Rocky Mountain Synod were \$2.7 million. The shortfall resulted in a reduction of about \$148,000 to ELCA Churchwide and a Rocky Mountain synod budget deficit of about \$146,000.

The executive committee of synod council has already revised the current budget with significant reductions to Pacific Lutheran Theological Seminary, campus ministry, outdoor ministry, health and wellness for leaders, Lutheran Family Services of Colorado, Lutheran Social Service of Utah, Lutheran Social Services of the South, Border Servant Corps, Urban Servant Corps, Lutheran Advocacy Ministry in Colorado and New Mexico, Global Missions Committee, Border Immersion Project, staff expenses, and support to our churchwide ELCA partnership.

Even so, projections still show a deficit for the current year of over \$100,000. Half of that will be additional reductions to ELCA churchwide. Synod Council will be considering additional RMS reductions.

The Church Council of the Evangelical Lutheran Church in America in November acted to reduce the 2010 churchwide current fund spending authorization by nearly \$7.7 million, 10 percent less than the budget authorized by the 2009 Churchwide Assembly. The council's action eliminated 40.75 full-time equivalent positions, of which six were vacant.

Meanwhile, the ministry and mission of the ELCA continues with stalwart faithfulness in the face of challenge. ELCA gifts to Haiti Earthquake Response have exceeded \$3.6 million. The work of the church continues...

*This new ministry team proposes and oversees the ways in which our synod promotes wellness and addresses conflict. Both congregations and leaders (lay and rostered) are the focus of encouraging health and wellness.*

## Congregational Ministries Board

*Works with Synod Council to identify major needs and areas of concern in all areas of congregational life and mission.*

## Mission Outreach Board

*Oversees the development of new congregations and the renewal of existing congregations within the Rocky Mountain Synod.*

## Global Missions Board

*Oversees our Companion Synods Program, arranges for immersion experiences, and provides education surrounding issues of global justice.*

## Committee on Discipline

*Provides part of the due process required when a party is accused of something for which they can be disciplined. This may include congregations, rostered leaders or members of congregations.*

## Consultation Committee

*When there is disagreement among factions within a congregation on a substantive issue that cannot be resolved by the parties, members of a congregation shall have access to the synodical bishop for consultation after informing the chair of the Congregation Council of their intent. If the consultation fails to resolve the issue(s), the Consultation Committee of this synod shall consider the matter.*
