Grant Types	Grant Amounts	Grant Incentive	Maximum Possible	How often can I apply?
Education Debt Relief (seminary & undergraduate)	10% of student loan balance (2022: increase to 20%)	N/A	\$10,000	One-time (2022: eligible to re-apply)
Medical Debt Relief	Up to \$2,000	Raise up to \$1K, match up to \$1K (2022: waived)	\$4,000	Annually
Emergency Relief	Up to \$1,000	N/A	\$1,000	Annually

Additional information:

Education Debt Relief

- Rostered ministers and candidates in final categories (Approved and/or Approved & Assigned) are eligible
- Best suited for those on a standard repayment plan

Medical Debt Relief

- In 2022 only, 3E Emergency funds will be utilized to increase the maximum amount of grant.

Emergency Relief

- All possible avenues of alternative relief should be investigated and applied for, including use of personal savings and available credit.
