#### **Education Debt Relief**

- Rostered ministers and candidates in final categories (Approved and/or Approved & Assigned) are eligible
- Best suited for those on a standard repayment plan

#### Medical Debt Relief

• A contribution to the 3E program raised by either the congregation/ministry or a source other than the grant applicant can be considered for matching funds

### **Emergency Relief**

• All possible avenues of alternative relief should be investigated and applied for, including use of personal savings and available credit.
