## I have a 3E story

I'm in a part-time call with a salary under \$30,000 a year. My husband and I relocated and are still paying off moving expenses since he had been downsized for two years before we moved to Colorado. His new firm didn't pay moving expenses, so we have a loan for that. I was unable to afford four new tires since we don't want to incur any credit card debt. I was driving on Interstate Highway 25 the night before I was informed that I had been given the emergency grant. There was a heavy rainstorm and I was coming back from a cottage meeting, and the car was slipping a lot due to the worn-out tires. The next day, I received the email [telling me] that I had been awarded the \$1,000 grant. I am so very grateful! I had new tires on the car within two days, and was able to replace an old radiator hose before I had a problem with overheating. I am very appreciative that I can drive safely now! Thank you so very much! It was very helpful not to incur debt to buy tires, as it helped our overall financial condition. - Anonymous

I was encouraged to apply for the Lilly Grant by a synod staff person when I shared that we were struggling with significant medical debt. My congregation was quick to find the \$1,000 matching donation that resulted in receiving a \$2,000 grant from Lilly. The whole process felt very supportive from the synod, my congregation and from Lilly. My husband and I were so grateful for the help, and I was able to breathe a little easier and feel some relief from the stress around our financial concerns. The generosity I received lifted my spirits and helped me feel renewed energy and focus in my ministry. *—Anonymous* 

I'm in my first call as a pastor and have been facing tremendous student loan debt, along with the challenge of a first-call salary. Midway through the year, I agreed to take custody of my special-





needs nephew for the sake of his own growth as a child of God. Along with the challenges of someone with developmental disabilities, he was bullied and being led down a path that was unhealthy and emotionally painful. By taking on the responsibility of caring for his needs, along with the costs that went with it, I was facing even more challenging financial problems. The 3E grant is an amazing gift and opportunity for me to be able to continue to care for him and catch up on expenses that I was having difficulty with. I'm so very grateful and thankful for the support of not only the financial assistance but, more importantly, the care, compassion and prayers that my fiscal wellness advocate and 3E leadership have provided me in these challenging times. -Anonymous

I am the pastor of a fairly small congregation and my salary will probably never be fully up to synod guidelines. I believe it is my responsibility to live within my salary and make wise financial choices. However, there isn't much extra to add to my retirement fund, which is already diminished because of my limited income. While this grant won't bring me up to what I might have in my retirement if I had made different congregational

> choices, it is rewarding to know that the larger church recognizes the lifelong financial challenge that is part of being a pastor in a small congregation. I am very thankful! —*Anonymous* **L**
